To Whom It May Concern:

The Clarion County Housing Authority is requesting proposals for trash pick-up and removal services at several of our housing developments and our administrative office location. Vendors are not required to submit proposals for all locations; proposals may be submitted for individual developments or specific service areas if preferred.

The contract term will run from July 1, 2026, through June 30, 2028, with the possibility of a one-year extension or a shorter extension period upon mutual agreement.

Some trash areas currently utilize dumpsters. It will be the contractor's responsibility to determine the appropriate dumpster sizes and the frequency of service required for each location. While suggestions are provided based on the Housing Authority's past experience, the contractor should evaluate each site to ensure adequate service levels.

The Housing Authority expects all trash areas to be maintained in a clean and orderly condition at all times, including during holiday periods. When dumpsters are serviced, the contractor must also remove and dispose of any overflow or debris surrounding the dumpster area. This contract includes the complete removal of trash and the cleanup of all designated trash areas.

If you are interested in submitting a proposal, please complete and return the "Proposal for Trash Pick-Up and Removal" form (4 pages) to the Housing Authority **no later than 4:30 p.m. on April 2, 2026**.
